What is the principle behind Chèques Transmission?

SOWALFIN Transmission gives you access to a [network of approved transfer experts](#).

You can get a subsidy to cover part of the costs of their services.

NB. You will only be eligible to qualify for these subsidies if you use one of the approved service providers under the Chèques Entreprises scheme, in the “Transmission” category.

Who is eligible for Chèques Transmission?

Chèques Transmission are intended for two types of recipients:

1. SMEs or self-employed persons carrying out a business activity and whose principal place of business is in Wallonia;
2. Project promoters (private individuals or those engaged in complementary self-employment) who present a project that is likely to lead to the takeover of a business that is/will be based in Wallonia.

How much can you receive?

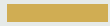
THE CHÈQUES TRANSMISSION ‘DIAGNOSTIC’

For this first stage, you can receive:

- 75% of the costs of the service,
- with a maximum amount of EUR 7 000 (excluding VAT) over 3 years.

Types of costs covered are costs relating to a set of services linked to a request for a diagnosis or inventory, with a view to preparing and supporting you through the transfer or takeover process.

Receive subsidies for transferring or taking over a business



Depending on the project promoter or recipient undertaking's level of preparation, eligible services in the context of a transfer or takeover diagnosis may consist of:

- a diagnosis or inventory,
- strategic recommendations: action plan,
- a valuation,
- legal advice, excluding tax advice,
- various audits.

THE CHÈQUES TRANSMISSION 'ACCOMPAGNEMENT'

Only accessible after a diagnosis has been completed, for this second stage you can receive:

- 50% of the costs of the service,
- with a maximum amount of EUR 15 000 (excluding VAT) over 3 years.

Types of costs covered through the Chèque Transmission 'Accompagnement' are costs relating to consultancy fees, following the transfer or takeover diagnosis and linked to the transfer or takeover of a business, such as, in particular:

- a valuation of the business,
- search for counterparties (buyers or sellers),
- drawing up a transfer agreement,
- legal advice, excluding tax advice,
- financial, social and environmental audits.
- ...

In addition, costs relating to strategic support and management advice for the purchaser during a post-takeover period of no more than 3 years from the date of signature of the transfer agreement are also covered.

How can I obtain a subsidy?



For all Chèque Transmission 'Diagnostic' requests, SOWALFIN Transmission provides a certificate to validate the eligibility of the services. The following conditions must be met in order for SOWALFIN Transmission to be able to deliver the certificate:

- direct contact established with the recipient,
- receipt, if applicable, of the results of the online test (for the transferor - [Test Transmission](#) or for the purchaser - [Test Repreneur](#)),
- receipt of the engagement letter signed by the service provider and the recipient (transferor or purchaser),
- validation of the chosen service provider (certified and approved by SOWALFIN Transmission).

NB. Under no circumstances may the service delivery assignment start until you have received an email from the platform Chèques Entreprises explicitly informing you that you may start using the service.

The Chèque Transmission 'Accompagnement' may only be requested after the 'Diagnostic' service has been provided.
